

EXHIBIT G-1

Legal Description

All that tract or parcel of land lying and being in Land Lot 154 of the 7th District of Gwinnett County, Georgia, and being more particularly described as follows:

Begin at a point on the northwesterly right-of-way line of Satellite Boulevard (100-foot right-of-way) at the south end of the mitered intersection of said right-of-way line of Satellite Boulevard with the northeasterly right-of-way line of Shawnee Ridge Court (60-foot right-of-way); run thence along said mitered right-of-way line North 84 degrees 59 minutes 08 seconds West 28.89 feet to a point on the northeasterly right-of-way line of Shawnee Ridge Court; thence along said right-of-way line the following courses and distances: North 41 degrees 10 minutes 00 seconds West 59.86 feet; along the arc of a 170.00 foot radius curve to the right an arc distance of 39.69 feet (said arc being subtended by a chord having a bearing of North 34 degrees 28 minutes 43 seconds West and a length of 39.60 feet); North 27 degrees 47 minutes 27 seconds West 124.16 feet; along the arc of a 230 foot radius curve to the left an arc distance of 34.24 feet (said arc being subtended by a chord having a bearing of North 32 degrees 03 minutes 22 seconds West and a length of 34.21 feet); North 36 degrees 19 minutes 18 seconds West 218.79 feet; and along the arc of a 310 foot radius curve to the left an arc distance of 33.23 feet (said arc being subtended by a chord having a bearing of North 39 degrees 23 minutes 34 seconds West and a length of 33.22 feet); thence leave said right-of-way line and run North 57 degrees 50 minutes 25 seconds East 524.50 feet to a point; thence South 32 degrees 09 minutes 36 seconds East 500.00 feet to a point; thence South 12 degrees 50 minutes 24 seconds West 28.28 feet to a point located on the northwesterly right-of-way line of Satellite Boulevard; thence along said right-of-way line of following courses and distances: South 57 degrees 50 minutes 24 seconds West 358.96 feet; and along the arc of a 961.95 foot radius curve to the left an arc distance of 101.19 feet to the Point of Beginning (said arc being subtended by a chord having a bearing of South 54 degrees 49 minutes 34 seconds West and a length of 101.15 feet); said tract containing 6.098 acres as shown on that plat of survey for Bergen-Brunswick, Site K-1, Lot 1, Blk. "A", Unit Two, Shawnee Ridge, dated March 30, 1993, last revised April 8, 1993, prepared by Precision Planning, Inc., Jeff H. Griffin, Georgia Registered Land Surveyor No. 2503.

EXHIBIT G-2

All that tract or parcel of land lying and being in Land Lot 154 of the 7th District of Gwinnett County, Georgia, and being more particularly described as follows:

Beginning at an iron pin set on the northern right-of-way line of Shawnee Ridge Court (60-foot right-of-way) 528.72 feet northerly along said right-of-way line from the intersection of said right-of-way line with the western right-of-way line of Satellite Boulevard (100-foot right of-way), if said rights-of-way were extended; continue along said right-of-way line of Shawnee Ridge Court along the arc of a 300-foot radius curve to the left an arc distance of 50.00 feet to an iron pin set (said arc being subtended by a chord having a bearing of North 47 degrees 14 minutes 20 seconds West and a length of 49.94 feet); thence leave said right-of-way line and run North 42 degrees 13 minutes 01 seconds East 70.00 feet to an iron pin set; run thence North 32 degrees 09 minutes 35 seconds West 106.09 feet to an iron pin set; run thence North 57 degrees 50 minutes 25 seconds East 470.08 feet to an iron pin set; run thence South 32 degrees 09 minutes 36 seconds East 173.16 feet to an iron pin found; run thence South 57 degrees 50 minutes 25 seconds West 524.50 feet to an iron pin set on the northern right-of-way line of Shawnee Ridge Court and the True Point of Beginning; said tract being designated as Tract 2 and containing 1.952 acres on that Boundary Survey for Industrial Developments International, Inc. Shawnee Ridge Unit II, dated July 18, 1995, last revised November 17, 1995, prepared by Precision Planning, Inc., and bearing the seal and certification of Anthony Mark Veal, Georgia Registered Land Surveyor No. 2651, said survey being incorporated herein by this reference.

ALL THAT TRACT or parcel of land lying and being in Land Lot 151, 7th District, Cvilanett County, Georgia, and being more particularly described as follows:

To find the point of beginning, commence at a point on the northeast right of way line of Shames Ridge Court (having a 66 foot right of way) 486.73 feet northwesterly along the right of way line from the intersection of the northeast right of way line of Shames Ridge Court with the north right of way line of Satellite Blvd. (having a 100 foot right of way) if extended to form an angle instead of a curve; run thence along a curve to the left having a radius of 210.00 feet and an arc length of 33.24 feet, being subtended by a chord of North 33 degrees 37 minutes 35 seconds West for a distance of 33.22 feet to a point; thence along a curve to the left having a radius of 300.00 feet and an arc length of 80.00 feet, being subtended by a chord of North 47 degrees 14 minutes 20 seconds West for a distance of 49.84 feet to a point; thence along a curve to the left having a radius of 300.00 feet and an arc length of 153.24 feet, being subtended by a chord of North 56 degrees 38 minutes 47 seconds West for a distance of 151.58 feet to a point; thence along a curve to the left having a radius of 226.50 feet and an arc length of 63.62 feet, being subtended by a chord of North 59 degrees 59 minutes 40 seconds West for a distance of 60.75 feet to a point; thence south 51 degrees 14 minutes 17 seconds West for a distance of 20.17 feet to a 1/2 inch rebar pin set; run thence along a curve to the left having a radius of 300 feet and an arc length of 118.6 feet, being subtended by a chord of South 68 degrees 36 minutes 35 seconds West for a distance of 117.83 feet, to a point; run thence south 58 degrees 37 minutes 03 seconds West a distance of 251.62 feet to a point; thence along a curve to the left having a radius of 530 feet and an arc length of 164.25 feet, being subtended by a chord of South 49 degrees 44 minutes 22 seconds West a distance of 162.55 feet, to a point; thence south 40 degrees 51 minutes 41 seconds West a distance of 15.39 feet to a point; thence along a curve to the left having a radius of 60.00 feet and an arc length of 31.49 feet, being subtended by a chord of South 61 degrees 57 minutes 11 seconds West for a distance of 78.17 feet, to a 1/2 inch rebar pin set; thence North 66 degrees 57 minutes 18 seconds West a distance of 30.00 feet to a 1/2 inch rebar pin set, which point is the TRUE POINT OF BEGINNING; running a point marked by a 1/2 inch rebar pin set; running thence north 21 degrees 22 minutes 58 seconds West a distance of 443.48 feet to a point marked by a 1/2 inch rebar pin set; running thence North 54 degrees 17 minutes 02 seconds East a distance of 63.62 feet, to a point; running thence South 31 degrees 22 minutes 57 seconds East a distance of 217.69 feet to a point; and running thence South 28 degrees 08 minutes 41 seconds East a distance of 292.25 feet to the TRUE POINT OF BEGINNING, containing .612 acres and shown as Tract 2 on plat of survey prepared by Precision Planning, Inc., certified by Anthony Mark Veal, A.L.S. No. 2651, dated May 9, 1995 and last revised December 5, 1995, said survey being incorporated herein by reference.

ALL THAT TRACT or parcel of land lying and being in Land Lot 154, 7th District, Gwinnett County, Georgia, and being more particularly described as follows:
